STATE STREET CORPORATION REDUZ PARTICIPAÇÃO NA EDP PARA 1,74%

Lisboa, 25 de Junho de 2020: Nos termos e para os efeitos do disposto no artigo 244º do Código dos Valores Mobiliários e do Regulamento n.º 5/2008 da CMVM, a EDP – Energias de Portugal, S.A. (“EDP”) vem prestar a seguinte informação ao mercado e ao público em geral:

No dia 25 de Junho de 2020, a State Street Corporation comunicou à EDP, nos termos dos números 1 e 2(b) do artigo 16.º do Código dos Valores Mobiliários, que detém uma participação de 1,74% do capital social e dos direitos de voto da EDP. A redução do patamar de 2% pela State Street Corporation ocorreu no dia 19 de Junho de 2020.

- in the circumstances foreseen in letter (e) of Article 10 of that Directive, the controlling natural person or legal entity and, provided it has a notification duty at an individual level under Article 9, under letters (a) to (d) of Article 10 of that Directive or under a combination of any of those situations, the controlled undertaking;

- in the circumstances foreseen in letter (f) of Article 10 of that Directive, the deposit taker of the shares, if he can exercise the voting rights attached to the shares deposited with him at his discretion, and the depositor of the shares allowing the deposit taker to exercise the voting rights at his discretion;

In case of multiple chains through which the voting rights and/or financial instruments are effectively held the chains have to be presented chain by chain leaving a row free between different chains (e.g.: A, B, C, free row, A, B, D, free row, A, E, F etc.).
