No dia 9 de Maio de 2022, o Bank of America Corporation comunicou que aumentou a sua participação no capital social da EDP para 5,325%. O patamar de 5% foi ultrapassado pela referida sociedade no dia 4 de Maio de 2022 (Anexo I).
